DESCRIBE IN DETAIL THE REVISION REQUESTED: Construct a Postmine Terrace in Sec. 7 on FC Land Co. property. Topsoil removal, grading, topsoil replacement, and revegetation on the areas disturbed in the "central mining area". A portion of the currently reclaimed ridge will be reduced in elevation with the material being moved north.

WHY IS THIS REVISION REQUESTED: To address remedies for drainage and surface water retention issues and to provide sight-line improvements for adjacent, off-permit property owners and a reduction in the grade of slopes for portions of the ridge.
